A special meeting of The City of Humphrey, Nebraska was convened in open and public session on Wednesday, July 21, 2021, at 7:00 p.m. at the Community Center. Present were Council-members Reigle, Eisenmenger, Bode and Mayor Preister. Absent: Nolan. Notification was given thereof by publication and a copy of that proof of publication was simultaneously given to the Council of this meeting. Mayor Preister called the meeting to order and, at the beginning of the meeting, informed the public of the location in the meeting room of the posted, current copy of the Nebraska Open Meetings Act. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

The purpose of the special meeting was for the second reading of Ordinances No. 763 and No. 764. No residents were present.

Mayor Preister read for the second time Ordinances #763 and #764.

Ordinance No. 763 came up for a second reading at the meeting of the Mayor and City Council on July 21, 2021. Ordinance No. 763 was read by title for the second time. Whereupon Council member Eisenmenger moved that Ordinance No. 763 be approved on its second reading. Council member Bode seconded the motion. The Mayor stated the question was, "Shall Ordinance No. 763 be approved on its second reading?" Upon roll call vote, the following Council members voted YEA: Eisenmenger, Bode, Reigle. The following voted NAY: None. Absent: Nolan. The approval of said Ordinance No. 763 upon its second reading having been concurred by a majority of all members of the Council, the Mayor declared said Ordinance No. 763 approved on its second reading.

Ordinance No. 764 came up for a second reading at the meeting of the Mayor and City Council on July 21, 2021. Ordinance No. 764 was read by title for the second time. Whereupon Council member Bode moved that Ordinance No. 764 be approved on its second reading. Council member Reigle seconded the motion. The Mayor stated the question was, "Shall Ordinance No. 764 be approved on its second reading?" Upon roll call vote, the following Council members voted YEA: Bode, Eisenmenger, Reigle. The following voted NAY: None. Absent: Nolan. The approval of said Ordinance No. 764 upon its second reading having been concurred by a majority of all members of the Council, the Mayor declared said Ordinance No. 764 approved on its second reading.

A motion was made by Bode and seconded by Eisenmenger to adjourn the meeting at 7:30 p.m. The motion carried on the following roll call vote: Yeah: Bode, Eisenmenger, Reigle. Nay: None. Absent: Nolan.
